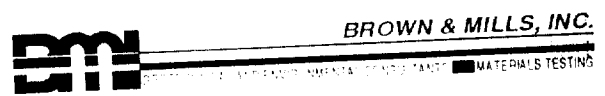

Observations / Comments Observed installation of 10 - #4 dowels and 8 - #5 dowels into existing concrete slab or footings. ~~Dowels~~ Holes drilled within concrete slab or footings extended at least 6 inches into concrete and were 5/8" in diameter (for #4 dowels) or 3/4" diameter (for #5 dowels). Holes were cleaned using a wire brush and compressed air. Simpson SET PAC High-Strength Epoxy-Tie adhesive (ICBO # ~~ER~~ ER 5279) was inserted into holes, followed by the dowels. Epoxy-anchored dowels appeared to be installed according to the manufacturer's recommendations.
