Establish Capital Improvement Projects and Appropriation of Funds to Various Park Projects

BACKGROUND

- A. The Department of Youth, Parks, & Community Enrichment wishes to expedite certain park improvement projects for scheduling considerations related to funding, design, construction, and project delivery issues to meet grant funding deadlines.
- B. Sufficient funds are available in various funding sources to support the budget transfers.
- C. The Sacramento Housing and Redevelopment Agency's (SHRA) Community Development Block Grant (CDBG) 2022 Action Plan included the following allocations: \$50,000 for the 21St Avenue Park Site Plan and \$80,000 for the Wood Park Community Garden. In order to transfer the funds, the City of Sacramento has entered into an Individual Project Agreement (IPA) with SHRA.
- D. The State of California's Per Capita Grant included an allocation of \$177,952 towards Hagginwood Park Soccer Field Renovation Project and will be supplemented with Measure U funding to complete the project.
- E. The State of California's Prop 68 Grant included an allocation of \$3,251,550 for Renfree Field Phase 1 Project.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. The following new capital improvement projects are hereby established:
 - a. Garcia Bend Park Court Renovation (L19120300);
 - b. Shore Park Improvements (L19159600);
 - c. 21st Avenue Park Site Plan (L19100500);
 - d. Wood Park Community Garden (L19208200).

- Section 2. The City Manager or the City Manager's designee is authorized to:
 - Increase the expenditure budget in the Garcia Bend Park Court Renovation (L19120300) project by transferring \$275,000 from CD7 Park Signs and Minor Improvements (L19013900) General Fund (Fund 1001);
 - Increase the expenditure budget in the Shore Park Improvements
 (L19159600); project by transferring \$50,000 from CD7 Park Signs and Minor Improvements (L19013900) General Fund (Fund 1001).
- Section 3. The following revenue and expenditure budgets are approved:
 - a. 21st Avenue Park Site Plan Park (L19100500) is established in the amount of \$50,000 from the CDBG Fund (Fund 2700);
 - b. Wood Park Community Garden Project (L19208200) is established in the amount of \$80,000 from the CDBG Fund (Fund 2700).
 - c. Hagginwood Park Soccer Field Renovation (L19703700) project in the amount of \$177,952 from Other Capital Grants Fund (Fund 3704).
 - d. Citywide Park Improvement Projects (L19300000) to fund sub-project Renfree Field Phase 1 Design project in the amount of \$3,251,550 from Other Capital Grants Fund (Fund 3704);
 - e. Park Site SN2 Master Plan and Phase 1 Improvements (L19290000) project in the amount of \$25,000 from the CDBG Fund (Fund 2700);
 - f. O'Neil Park Restroom Replacement (L19145500) project in the amount of \$450,000 from the CDBG Fund (Fund 2700);
 - g. Mangan Park Improvements (L19210200) project in the amount of \$350,000 from the CDBG Fund (Fund 2700);
 - h. Mama Marks Park Improvements (L19196200) project in the amount of \$600,000 from the CDBG Fund (Fund 2700).
- Section 4. The City Manager or the City Manager's designee is authorized to:
 - a. Increase the expenditure budget in the Hagginwood Park Soccer Field Renovation (L19703700) project by transferring \$250,000 from Measure U Park Improvements (L19706000) Measure U (Fund 2401);

b. Increase the expenditure budget in the Cabrillo Park Irrigation (L19111700); project by transferring \$50,000 from Measure U Park Improvements (L19706000) Measure U (Fund 2401).
