ORDINANCE AMENDING SECTION 27.60 (g)  
AND ADDING SECTION 27.170 OF THE  
SACRAMENTO CITY CODE RELATING TO  
RECREATION AND PARKS

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO AS FOLLOWS:

SECTION 1.

Subsection (g) of Section 27.60 is hereby amended to read as follows:

(g) A service fee if any established by resolution of the City Council will be charged for the use of all clubhouse facilities. All reservations must be paid five days in advance. No reservation will be considered as complete until the payment of the required fee, if any, and no refunds of service fees will be made.

SECTION 2.

Section 27.170 is hereby added to the City Code to read as follows:

Sec. 27.170 Schedule for Uses and Capacity of Parks.

The Director shall promulgate a schedule which shows uses and capacities of each park. Such schedule shall be adopted by and may be amended by resolution of the City Council.

SECTION 3

This ordinance shall be published in full within 10 days following adoption.

ORDINANCE AMENDING SECTION 27.60 (g)

SECTION 1.
