STAFF RECOMMENDATION

It is recommended that, in the best interest of the City, the City Council adopt the specifications used in the bidding process and accept the lowest responsible bid submitted for the contract resulting from Bid No. 1640 for Repair and/or Rebuilding of Allison Transmissions. Award is being recommended to F. B. Hart Company, 1441 Richards Blvd., Sacramento, CA 95814, in the amount of \$120,000.00.

SUMMARY

Attached is a tabulation of sealed proposals received by the City Clerk for furnishing services in accordance with the specifications used in the bidding process, and recommendation of bid award for Bid No. 1640 for Repair and/or Rebuilding of Allison Transmissions, to be used by the Fleet Management Division of the Public Works Department.

BACKGROUND

This contract will be used by the Fleet Management Division and is for the repair and/or rebuilding of Allison transmissions as required during the contract period. Allison transmissions are commonly used in larger vehicles, such as refuse trucks, dump trucks and sewer maintenance trucks.

Specifications for Bid No. 1640 were publicly advertised and mailed by the City Clerk. Initial advertising and mailing to vendors, bid advertising firms and minority outreach agencies began on April 20, 1994. Sealed bids were publicly opened by the City Clerk on May 11, 1994.

The following is a summary of the recommendation for contract award:

FINANCIAL CONSIDERATIONS

Sufficient funds have been or will be budgeted by the Fleet Management Division for this service under budget line 420-310-3159-4241 for maintenance and repair.

POLICY CONSIDERATIONS


This recommendation is consistent with the requirements for competitive bidding as detailed in Title 57 of the Sacramento City Code.

MBE/WBE EFFORTS

Requests for bid (RFB) were sent to five contractors, none of which were identified as M/WBE firms. Staff researched the City bid list, the EBMUD Minority and Women Business Enterprise 1992-93 Directory and the State of California - Winter 1994 Disadvantaged Business (DB) and Women Business Enterprise (WBE) List. No M/WBEs were identified for this type of heavy duty transmission repair/service. However, in an effort to encourage and locate M/WBE participants, the RFB was sent to several bid advertising agencies, including the Minority Business Exchange and the Sacramento Business Development Center. This bid also

included provisions for a five percent (5%) bid evaluation preference for City-certified, preference-eligible M/WBE firms. Of the two (2) bids received, neither is an M/WBE firm.
