The following information describes the usage intended for the mezzanine area above the restrooms and key shop in the warehouse area at 320 Commerce Circle:

- Raised area (24' X 40') will be used for monthly meetings and it will accommodate approximately 30-50 employees.
- 8 employees will use the lower area (24' X 24') for approximately 1.5 hours in the A.M. and 1.0 hours in the P.M. daily.
- Cubicle partitions will be erected to divide the portion in the lower area for individual use by staff.
- Construction of second egress will comply with code and it will exit from lower area.
