Due to a very wet conditions of recent rains, we have found that ascertaining proper drainage and finish grade on completed homes to be impossible at this time.

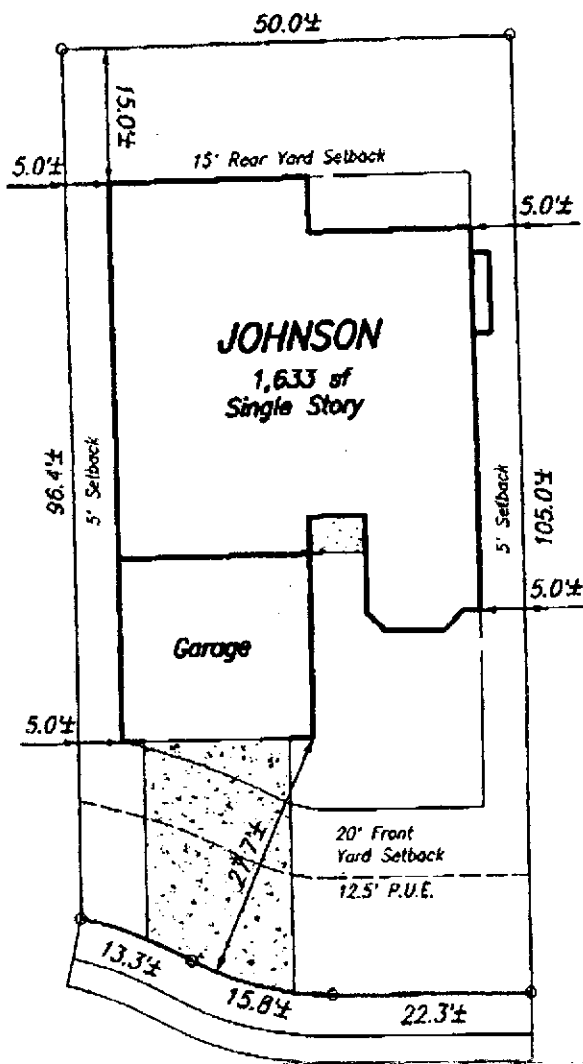

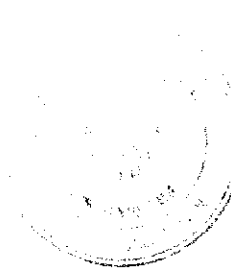
