DEAR SRAPC MEMBER:

THE BOARD OF SUPERVISORS OF SUTTER COUNTY GIVES GREAT WEIGHT TO THE RESOLUTIONS RECENTLY ADOPTED BY THE SACRAMENTO CITY COUNCIL AND THE SACRAMENTO BOARD OF SUPERVISORS DECLARING THEIR INTENTS TO WITHDRAW MEMBERSHIP FROM THE SACRAMENTO REGIONAL PLANNING AGENCY.

THE SUTTER COUNTY BOARD OF SUPERVISORS IS GIVING PRIORITY CONSIDERATION TO THE POTENTIAL IMPACTS OF THIS ACTION ON SUTTER COUNTY'S INTERESTS, THE INTERESTS OF THE "RURAL" MEMBERS OF SRAPC AND THE INTERESTS OF THE REGION AS A WHOLE. THE ISSUES INVOLVED ARE BOTH POLITICALLY AND ADMINISTRATIVELY COMPLEX AND THERE ARE A NUMBER OF ALTERNATIVES TO THE EXISTING STRUCTURE WHICH REQUIRE CAREFUL EVALUATION BY ALL OF THE MEMBER ENTITIES.

THE INTERGOVERNMENTAL RELATIONS ADVISORY COUNCIL (IRAC), CONSISTING OF REPRESENTATIVES OF SUTTER COUNTY, YUBA COUNTY AND THE CITIES OF MARYSVILLE, YUBA CITY, LIVE OAK AND WHEATLAND, HAS RECENTLY REQUESTED THE SRAPC STAFF TO PREPARE AN ANALYSIS OF VARIOUS VOTING AND DECISION-MAKING ARRANGEMENTS AND THE ADVANTAGES AND DISADVANTAGES OF ITS MEMBERS REMAINING IN SRAPC VS ALTERNATIVE FORMS OF ORGANIZATION. THAT STUDY HAS NOT YET BEEN COMPLETED.

THE SUTTER COUNTY BOARD OF SUPERVISORS DOES NOT BELIEVE THAT THE TIME FRAME ESTABLISHED IN THE RESOLUTIONS ADOPTED BY THE CITY OF SACRAMENTO AND THE COUNTY OF SACRAMENTO PROVIDES AMPLE OPPORTUNITY FOR THE ENTITIES TO REACH A FULLY CONSIDERED DECISION ON THIS IMPORTANT MATTER.


