SUBJECT: Resolution Authorizing Refund of Bridge Fees for Mesa Grande Unit

No. 4 Subdivision (P-8686)

SUMMARY:

Attached hereto is a resolution authorizing the refund of bridge fees, pursuant to Paragraph 38 of City Agreement No. 81068, to H. C. Elliott, Inc., subdivider for the Mesa Grande Unit No. 4 subdivision. Approval of the resolution is recommended.

BACKGROUND:

On October 27, 1981 the City Council approved for recordation a final subdivision map for Mesa Grande Unit No. 4 subject to the execution of a Subdivision Improvement Agreement providing for various improvements, including the deposit of a fee for the subdivision's prorata share of future bridge construction costs over Unionhouse Creek. The Subdivision Improvement Agreement provides for a deposit of \$15,476.00 for Unionhouse Creek Bridge costs and for the refund of this amount if the proposed bridge construction is not accomplished. The City Engineer believes that the bridge abutting the subdivision over Unionhouse Creek will not be constructed in the forseeable future and therefore recommends that \$15,476.00 be refunded to the subdivider, H. C. Elliott, Inc.

RECOMMENDATION:

It is recommended that \$15,476.00 be refunded, without interest, to H. C. Elliott, Inc., by passage of the attached resolution.

AUTHORIZING REFUND OF BRIDGE FEES PURSUANT TO CITY AGREEMENT NO. 81068, RELATING TO MESA GRANDE UNIT NO. 4 SUBDIVISION (P-8686)

WHEREAS, on October 27, 1981 in City Resolution No. 81-777 the City Council approved for recordation a final subdivision map for Mesa Grande Unit No. 4 subject to the execution of a subdivision improvement agreement providing for various improvements, including the deposit of a fee for the subdivision's prorata share of future bridge construction costs over Unionhouse Creek;

WHEREAS, paragraph 38 of said Subdivision Improvement Agreement, City Agreement No. 81068 provides for a deposit of \$15,476.00 for Unionhouse Creek Bridge costs and for the refund of this amount if the proposed bridge construction is not accomplished;

WHEREAS, the City Engineer believes that the bridge abutting the subdivision over Unionhouse Creek will not be constructed in the forseeable future and therefore recommends that \$15,476.00 be refunded to the subdivider;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

That pursuant to paragraph 28 of city Agreement No. 81068, \$15,476.00 be refunded, without interest, to H. C. Elliott, Inc., subdivider of Mesa Grande No. 4.
