SUBJECT: Grant Application to The Museum Program of The National Endowment For The Arts For a Papermaking Workshop

SUMMARY

A resolution is required to authorize the submittal of an application for a matching grant of \$775 for the Crocker Art Museum Division.

BACKGROUND INFORMATION

The proposal is for grant support of a two day workshop on papermaking to be held in conjunction with the paper art exhibition. The workshop will consist of lectures illustrating the history and contemporary techniques of hand-made paper and an all day session in which each of the participants will have the opportunity to make paper. The workshop will allow the general public to learn about the techniques and aesthetics of a rapidly growing artistic medium.

FINANCIAL DATA

Matching funds will exceed the grant requirements and consist of \$300 from workshop fees and \$505 the City will provide in indirect costs (salary and benefits). No direct City funds are requested.

RECOMMENDATION

It is recommended that the City Council, by resolution, authorize the City Manager to submit a grant application.
