SUBJECT: 63RD STREET/39TH AVENUE DRAINAGE IMPROVEMENTS PROJECT

(PN:WJ31) CONTRACT AWARD TO CON STAR CONSTRUCTION FOR AN

AMOUNT NOT TO EXCEED \$126,363

LOCATION AND COUNCIL DISTRICT:

The Sump 63rd Street/39th Avenue Drainage Improvements Project is located in Council District 6. See attached vicinity map.

RECOMMENDATION:

Staff recommends that the City Council accept the bid from Con Star Construction for an amount not to exceed \$126,363 and award the contract.

SUMMARY

Bids were received from six (6) contractors and opened by the City Clerk on September 22, 1999. The low bidder was Con Star Construction with a bid of \$126,363. Con Star Construction did meet the ESBD goals. It is therefore proposed to award the contract to Con Star Construction for \$126,363.

BACKGROUND INFORMATION

The existing 8" storm drain pipe in 63rd Street between 40th Avenue and McMahon Drive is undersized and old. A portion of it failed last year during cleaning and needed to be repaired. The new up sized pipe will require less maintenance and increase storm flow capacity thus reducing flooding in the area. The project includes:

- Replacing 560' of 8" pipe with 12" pipe
- Replacing 10 existing Drainage Inlets with Type B Drainage Inlets
- Constructing 8 new Handicap Ramps

Bids were received from six contractors, as follows:

Con Star Construction	\$126,363
Navajo Pipelines, Inc.	\$128,500
Jaeger Construction, Inc.	\$129,394
Biondi Paving, Inc.	\$149,770
Q.B.C., Inc.	\$159,175
Blackrock Paving, Inc.	\$189,578

The engineer's estimated construction cost was \$131,000. The estimated completion date is February 2000.

FINANCIAL CONSIDERATIONS

The total estimated cost for this project, including all design, construction, inspection and administration is \$160,500. There are sufficient funds in the project to award the contract and to complete the project.

ENVIRONMENTAL CONSIDERATIONS

This project is exempt from the provisions of the California Environmental Quality Act (CEQA), under section 15302. The project consists of the reconstruction of existing facilities which will continue to have the same purpose as the structure being replaced.

POLICY CONSIDERATION

This action is consistent with Chapter 58, Article III, Section 58.304 of the City Code concerning award of contract.

ESBD CONSIDERATIONS

This project included participation goals of 20% for emerging and small business enterprises as required by Ordinance 99-007 and Resolution 99-055, relating to ESBD participation goals and policies, adopted by the City Council on February 9, 1999. The responsive low bidder, Con Star Construction exceeded the ESBE goals with a participation level of 100%.




