
BE IT RESOLVED BY THE HOUSING AUTHORITY OF THE CITY OF SACRAMENTO:

Section 1. The Executive Director is hereby authorized and directed to execute a Contract with LUCHINI LANDSCAPING for landscape maintenance services at:


NEW HELVETIA HOUSING PROJECT - CAL 5-1 & 5-3
