SUBJECT: Amendment to the City of Sacramento's 1980-81
Community Development Block Grant (CDBG) Program

SUMMARY

This report regards a proposed amendment to the City of Sacramento's 1980-81 CDBG Program. The amendment involves the transfer of \$20,000 from the 1980-81 CDBG Contingency Fund to the Relocation Assistance Program.

The staff recommends the City Council adopt the attached resolution approving the proposed amendment and authorizing the City Manager to file the subject amendment with the Department of Housing and Urban Development.

BACKGROUND INFORMATION

On March 20, 1980, the City Council adopted the City's 1980-81 CDBG Program which included \$55,000 for the Relocation Assistance Program. This Program, implemented by the Sacramento Housing and Redevelopment Agency - Housing Rehabilitation Division, is to provide relocation assistance to about 25 low/moderate income homeowners and tenant occupants with moving expenses and rental of temporary housing displaced due to publicly assisted rehabilitation activity conducted through the CDBG Program. As of March 1981, the Rehabilitation Division had processed 28 cases; and has identified 12 additional families for relocation assistance. In order to provide relocation assistance to these families, the Agency is requesting an additional \$20,000.

The Relocation Assistance Program is an exempt project in accordance with NEPA (National Environmental Policy Act) and CEQA (California Environmental Quality Act). No additional environmental review will be required for the reallocation of additional funds for the Relocation Assistance Program.

FINANCIAL DATA


The net effect of the proposed resolution on the 1980-81 CDBG Program is as follows:

RECOMMENDATION


The staff recommends that the City Council adopt the attached resolution approving the subject amendment and authorizing the City Manager to file the amendment with the Department of Housing and Urban Development.
