This letter is to verify that for the above plan a 3050 window may be placed in the 12' shear wall at the right side of the house if the following repairs are completed:

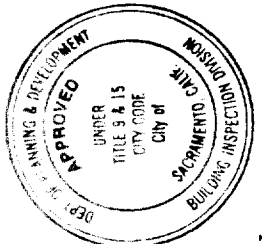
- A horizontal Simpson CS16 Strap 12' long must be installed above and below the window over 2X blocking.

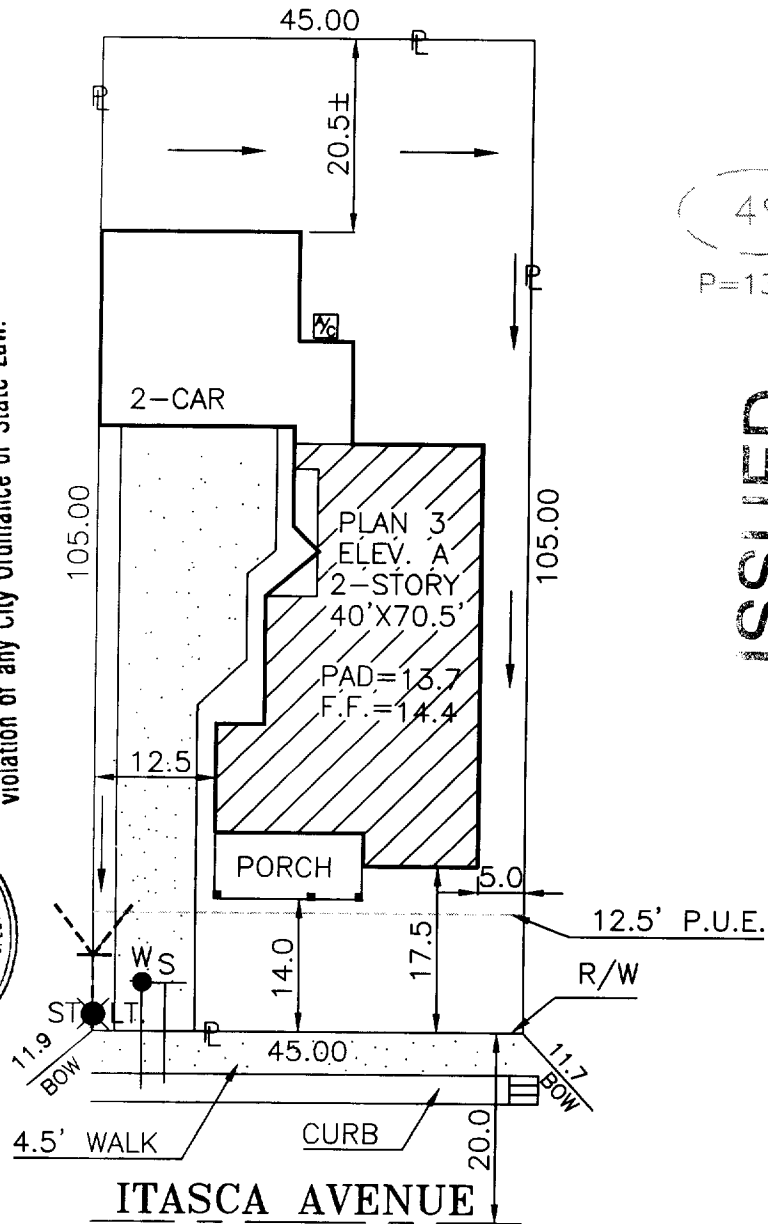

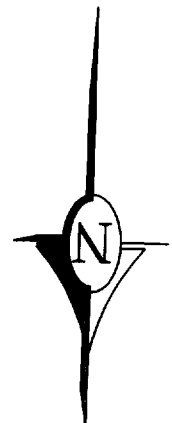
