To Whom it may concern:

Although nails are specified as the recommended attachment for our shingles, staples are occasionally used to fasten some of our composition shingles. The use of staples on the Ambassador Shingle is acceptable.

The Ambassador is one of the heaviest laminated shingles on the market, and carries an 85 mile per hour wind warranty. Celotex will issue a warranty on this roof, except 86 against wind blow offs.
