SUBJECT: CLUB CENTER DRIVE BRIDGE - REIMBURSEMENT/CREDIT AGREEMENT

LOCATION AND COUNCIL DISTRICT:

Club Center Drive Bridge across the East Drain, District 1, Neighborhood service area 4.

RECOMMENDATION:

This report recommends that Council approve the attached reimbursement agreement between the City of Sacramento, Lennar Winncrest LLC., and Northpoint Park LLC. related to the construction of Club Center Drive Bridge spanning the East Drain at Club Center Drive, (see attached map - Exhibit A).

SUMMARY:

Lennar Winncrest and Northpoint Park, are landowners in North Natomas, north of Del Paso Road and east of Interstate 5. Lennar Winncrest has begun development of single-family homes. As part of the development, they constructed the Club Center Drive Bridge across the Natomas East Drain.

The landowners have funded the construction costs. Upon review of cost documentation, the landowners will be eligible for reimbursement through the North Natomas Public Facilities Fee (PFF) and Major Street Construction Tax (MSCT).

COMMITTEE/COMMISSION ACTION:

None.

BACKGROUND INFORMATION:

Lennar Winncrest and Northpoint Park have funded and constructed the Club Center Drive Bridge spanning the East Drain at Club Center Drive. Upon review of bid documents, invoices and other cost documentation, the landowners will be eligible for reimbursement through the PFF and MSCT. Reimbursement may be paid to the Landowners over time as funds become available, or by the use of fee credits which can be applied to offset payment of the Public Facilities Fee.

FINANCIAL CONSIDERATIONS:

There will be no impact to the General Fund as a result of this project. The sole source of funding for Club Center Drive Bridge spanning the East Drain at Club Center Drive are Lennar Winncrest and Northpoint Park. The sole source of reimbursement to the landowner will be the North Natomas PFF and MSCT.

The landowners will reimburse to the City the sum of \$1,500 for the services of the City Attorney in preparing the agreement.

ENVIRONMENTAL CONSIDERATIONS:

The North Natomas EIR was approved by City Council on May 3, 1994. The City Council's action in approving this agreement is solely for the purpose of providing funding and reimbursement mechanisms for Club Center Drive Bridge and is itself therefore not a project for the purpose of the California Environmental Quality Act.
