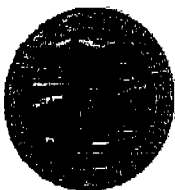

STAFF ACTION AND CONDITIONS OF APPROVAL:

Staff has reviewed the proposed project, and approves it with the following conditions of approval:

1. Provide smooth finish stucco to all four sides of existing home.
2. Provide decorative trim around all doors and windows. Windows shall have decorative trim and sills.
3. Street-facing gable vents shall be boxed out with stucco trim and sills.
4. Paint entire house, all gutters, exposed wood and trim shall be painted a complementary accent color.
5. The scope of exterior work is limited to the above listed items. Any changes are subject to Design Review staff approval.
