SUBJECT: Abandonment of a portion of the extensions of I and J Streets,

Improvement Proceeding No. 5177.

#### BACKGROUND INFORMATION

In 1972, the City deeded to the State of California the property lying between Front Street and the Sacramento River in Old Sacramento and retained an easement 80 feet in width for the extension of I Street and and J Streets from Front Street to the River. In 1980, it was determined that the 80 foot width was not necessary for the City's use and a portion of these easements was Quit Claimed back to the State. Attorneys for the State now feel that the Quit Claim Deed is inadequate for conveying title back to the State and have requested a full abandonment of these portions of I and J Streets.

#### FINANCIAL DATA

There is no cost or income to the City.

### RECOMMENDATION

It is recommended that the attached Resolution of Intention for said abandonments, which sets a hearing for March 31st, 1981, be adopted.

# RESOLUTION NO. 81-162

Adapted by The Sacramento City Council on date of

RESOLUTION OF INTENTION FOR IMPROVEMENT PROCEEDING NO. 5177

WHEREAS, in the opinion of the City Council of the City of Sacramento, the public interest and convenience require the abandonment of the following described public right of way as provided under the Street Vacation Act of 1941, Streets and Highways Code of the State of California.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Sacramento hereby declares its intention to abandon the following described public right of way in the City of Sacramento:

All that certain real property situate in the City of Sacramento, County of Sacramento, State of California, described as follows:

The North 20 feet of the North one-half of the westerly projection of J and the North 20 feet of the North one-half and the South 20 feet of the South one-half of the westerly projection of I Street lying between the westerly line of Front Street and the Sacramento River.

BE IT FURTHER RESOLVED AND OREDERED that on the 31st day of March, 1981, at the hour of 7:30 o'clock P.M., in the City Council Chambers of the City Council of the City of Sacramento on I Street between 9th & 10th Streets in said City, be, and the same is hereby fixed as the time and place for the hearing on the proposed abandonment of said public right of way.


BE IT FURTHER RESOLVED that the City Clerk be directed to publish notice of hearing of the proposed abandonment of said public right of way in the Daily Recorder, a newspaper published 5 times a week, as required by law, and that said notice be posted along the right of way to be abandoned in accordance with the provisions of the Street Vacation Act of 1941, Sections 8300 to 8324, Streets and Highways Code of the State of California.


