**REPEALING RESOLUTION 2011- 047, WHICH ESTABLISHED FIRE DEPARTMENT
MITIGATION RATES**

BACKGROUND

- A. On January 25, 2011, the City Council passed Ordinance 2011-007, relating to fire cost recovery. In conjunction with that ordinance, the Council adopted Resolution 2011-047, which set the rates for certain Fire Department services.
- B. On March 29, 2011, the City Council repealed Ordinance 2011-007.

**BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL
RESOLVES AS FOLLOWS:**

Section 1. Resolution 2011-047 is hereby repealed.
