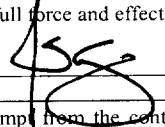

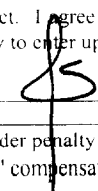

To whom it may concern:

This letter is to verify that for the above lot the following framing items have been addressed by this office:

- The over-bored stud at the tandem garage 2X4 framing may be repaired using a Simpson HSS2 Shoe.
- For the as-built connection of girder truss M4 (HGUS26-2), the B2 Truss bottom chord against the rim must be connected with a minimum of (10) 16d Sinkers within 18" of the hanger. The other side of the hanger is currently attached to a 2X block. This block must also have a minimum of (10) 16d Sinkers installed into the rim within 18" of the hanger.

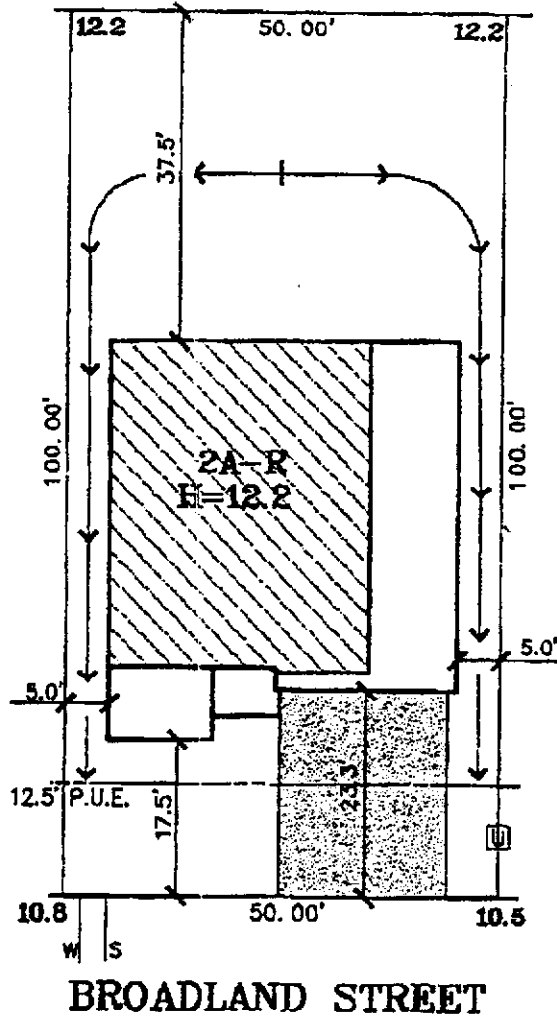
