SUMMARY

The Budget and Finance Committee has considered and approved staff's recommendation to eliminate the City's Bicycle Licensing Program.

DISCUSSION

Staff prepared an evaluation of the City's Bicycle Licensing Program (attachment A) which indicated:

1. The program was beginning to cost as much as the revenues being generated.
2. The program was not being actively administered.
3. The program only resulted in a seven percent (7%) property recovery.

Based upon the evaluation, staff recommended the City of Sacramento discontinue its program of licensing bicycles.

RECOMMENDATION

It is recommended that the City Council adopt the attached ordinance repealing the bicycle licensing provisions of the City Code.

ORDINANCE NO.

ORDINANCE RELATING TO BICYCLES
AND BICYCLE LICENSES

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO AS FOLLOWS:

SECTION 1. Sections Repealed.

Sections 25.71, 25.72, 25.73, 25.74, 25.75, 25.76, 25.77, 25.78, 25.79, 25.81, 25.82, 25.83, 25.84, 25.85, and 25.86 of the Sacramento City Code be and the same hereby are repealed.

SECTION 2.

Section 25.80 of the Sacramento City Code is hereby repealed and reenacted as Section 25.71 to read as follows:

Sec. 25.71 Police department authorized to number bicycle frames.

All bicycles shall have, as a means of identification, serial numbers stamped on the frame of the bicycle. The police department or persons authorized by the police chief may stamp numbers or symbols on the frames of bicycles not bearing manufacturers' serial numbers.

SECTION 3.

Section 25.72 of the Sacramento City Code is hereby enacted to read as follows:

Sec. 25.72 Responsibility of parent or guardian; penalties.

(a) No parent of any child or the guardian of any ward shall authorize or knowingly permit any such child or ward to violate any of the provisions of this article.

(b) Any violation of this article shall be deemed to be an infraction. The fine imposed for any such violation shall not exceed the sum of five dollars (\$5.00).
