In accordance with City of Sacramento special inspection requirements, our firm has performed *Special Inspection and Testing* in accordance with Sections 106 and 1701 of the Uniform Building Code for the subject project. Our observation and test results indicate that the following items were constructed, to the best of our knowledge, in accordance with the project's plans and specifications:

**Masonry:** Verified installation of missing horizontal steel in existing 8" CMU perimeter sound wall. Checked grout spaces for cleanliness prior to closing clean outs for high lift grouting, observed grout placement and consolidation. Obtained samples for laboratory compression testing.

**Epoxy anchors:** Verified materials and observed correct installation procedures for epoxy rebar for out of tolerance masonry vertical wall dowels per epoxy system manufacturer's instructions.
