SUBJECT: APPROVAL OF CHANGE ORDER NO. 2 IN THE AMOUNT OF \$16,750.00 TALINI LANDSCAPING, INC. FOR THE POCKET CANAL PARKWAY PHASE 3B PROJECT (HB22)

LOCATION AND COUNCIL DISTRICT:

Pocket Canal from Pocket Road to Portuguese Park, Council District 7

RECOMMENDATION:

This report recommends that the City Council approve Change Order #2 with Talini Landscaping, Inc. in the amount of \$16,750.

SUMMARY

This report requests approval of Change Order #2 in the amount of \$16,750.00 for revisions to the fence installations along the Pocket Canal.

COMMITTEE/COMMISSION ACTION: None.

BACKGROUND INFORMATION

- This project is the third and final phase of improvements for the Pocket Canal Parkway.

- This contract was awarded by City Council on April 18, 1997, in the amount of \$282,963.24.
- This Change Order will compensate the contractor for differing site conditions encountered during installation of the fences.
- One previous City Manager change order has been issued totaling \$22,623.34 for grading changes required by differing site conditions encountered and ratification is recommended.

FINANCIAL CONSIDERATIONS

- The project budget for the Pocket Canal Parkway Project (HB22) is \$468,737.
- Additional funding for this phase of the project was authorized in the 1997/1998 Capitol Improvements Program.

ENVIRONMENTAL CONSIDERATIONS

On October 19, 1993, a Negative Declaration was adopted by the City of Sacramento for this project.

POLICY CONSIDERATIONS

Approval of this change order and the ratification and resetting of City Manager Change Order Authority, is consistent with Sacramento City Code, Title 58.

WBE/MBE EFFORTS

None. This action will modify an existing contract.
