Subject: Recommendation of Bid Award for LANDSCAPE DEVELOPMENT OF FLORIN ROAD

SUMMARY:

The subject project, as a part of the City's Capital Improvement Program has been advertised for bids. Bids have been received and the City Engineer hereby recommends bid award.

BACKGROUND:

On October 12, 1982, the City Council approved plans and specifications for the Landscape Development of Florin Road and bids were received and opened by the City Clerk in the Council Chambers on November 2, 1982. Bids received are as follows:


