

RESOLUTION OF INTENTION NO. 2796

WHEREAS, in the opinion of the City Council of the City of Sacramento, public interest and convenience require that the work and improvement hereinafter described, in the City of Sacramento, State of California, should be done:

NOW, THEREFORE, the said City Council of the City of Sacramento does hereby resolve and declare that it is the intention of the said City Council to order the following work and improvement to be done in said City, to-wit:

TO CLOSE, VACATE, AND ABANDON THE FOLLOWING:

23RD AVENUE (formerly Jefferson Avenue) from the Westerly boundary of Amended Plat No. 1 of Colonial Heights (as the same is shown on the official Plat thereof filed in the office of the Sacramento County Recorder) to the Easterly boundary of said Amended Plat No. 1 of Colonial Heights;

24TH AVENUE (formerly Franklin Avenue) from the Westerly boundary of said Amended Plat No. 1 of Colonial Heights to the Easterly boundary of said Amended Plat No. 1 of Colonial Heights;

54TH STREET (formerly Lafayette Avenue) from the Southerly boundary of said Amended Plat No. 1 of Colonial Heights to the Easterly and Westerly productions of Lots 68 and 67 of said Amended Plat No. 1 of Colonial Heights;

A Strip of Land 13 feet in width lying Southerly of and adjacent to Lots 59 to 76 inclusive of said Amended Plat No. 1 of Colonial Heights, designated on said Amended Plat No. 1 of Colonial Heights as reserved for Parks and Sidewalks;

A Strip of Land 13 feet in width lying Northerly of and adjacent to Lots 77 to 93 inclusive of said Amended Plat No. 1 of Colonial Heights, designated on said Amended Plat No. 1 of Colonial Heights as reserved for Parks and Sidewalks;

A Strip of Land 13 feet in width lying Southerly of and adjacent to Lots 94 to 109 inclusive of said Amended Plat No. 1 of Colonial Heights, designated on said Amended Plat No. 1 of Colonial Heights as reserved for Parks and Sidewalks;

A Strip of Land 13 feet in width lying Northerly of and adjacent to Lots 110 to 115 inclusive and Lots 117 to 125 inclusive of said Amended Plat No. 1 of Colonial Heights, designated on said Amended Plat No. 1 of Colonial Heights as reserved for Parks and Sidewalks;

A Strip of Land 14 feet in width lying Easterly of and adjacent to Lots 68, 84, 103 and 115 of said Amended Plat No. 1 of Colonial Heights, designated on said Amended Plat No. 1 of Colonial Heights as reserved for Parks and Sidewalks;

A Strip of land 14 feet in width lying Westerly of and adjacent to Lots 67, 85, 102 and 117 of said Amended Plat No. 1 of Colonial Heights, designated on said Amended Plat No. 1 of Colonial Heights as reserved for Parks and Sidewalks;

Parcels of Property designated as Parks in the Corners of Lots 76, 77, 109 and 110 as shown on said Amended Plat No. 1 of Colonial Heights;

Parcel of Property designated as a Park being 20 feet in diameter located at the intersection of 23rd Avenue (formerly Jefferson Avenue) and 54th Street (formerly Lafayette Avenue) as shown on said Amended Plat No. 1 of Colonial Heights, in the City of Sacramento,

And the said City Council does hereby determine and declare that said proposed work and improvement is of more than local or ordinary benefit, and will affect and benefit the lands and district hereinafter described, and which said district is hereby declared to be the district affected and benefited by said work and improvement and that therefore the entire damages, costs, and expenses of said work and improvement shall be and are hereby made chargeable against, and shall be assessed upon said lands and district, which district is within the City of Sacramento, County of Sacramento, State of California, and the exterior boundaries of the lands affected and benefited by said work and improvement are particularly described as follows, to-wit:

On the North by the Northerly lines of Lots 59 to 76 inclusive of said Amended Plat No. 1 of Colonial Heights,
On the East by the Easterly boundary of said Amended Plat No. 1 of Colonial Heights,
On the South by the Southerly boundary of said Amended Plat No. 1 of Colonial Heights,
On the West by the Westerly boundary of said Amended Plat No. 1 of Colonial Heights,

And the City Council does hereby elect to proceed to do said work under the provisions of Division 9 Part 3 Streets and Highways Code, the Street Vacation Act of 1941, being an Act of Legislature of the State of California, approved May 13th, 1941; and hereby fixes the 25th day of November, 1949 at 8:00 o'clock P.M., in the City Council Chamber in the Sacramento City Hall on I Street, between 9th and 10th Streets of said City, as the time and place when and where any and all persons interested in said work and improvement may appear before the said City Council of said City and be heard by said City Council upon such appeal, and show cause, if any they have, why the ~~tax~~ said improvement should not be made. The Sacramento Union is hereby designated as the daily newspaper published and circulated in said City, in which this Resolution shall be published; and the Superintendent of Streets is hereby directed to post notice of the passage of this Resolution in the manner prescribed by Law.
