STAFF ACTION AND CONDITIONS OF APPROVAL:

Staff has reviewed the proposed project, and approves it with the following conditions of approval:

1. Patch existing roof as needed, match existing.
2. Roof-mounted equipment is not permitted.
3. New porch, stairs, and rail on lower level to match those on adjacent 4-plex. Paint to match.
4. Repair and replace stairs and railings to match those on adjacent 4-plex. Paint to match
5. Patch and repair stucco, color and texture to match those on adjacent 4-plex
6. Front entry door shall have a raised panel design.
7. Paint all to match adjacent 4-plex
8. The scope of work is limited to the above listed items. Any changes are subject to Design Review staff approval.
