SUMMARY

This report recommends the City Council grant citation and arrest authority to certain employees of the Department of Planning and Development, Code Enforcement Section, as authorized by Article III of Chapter 30, of the Sacramento City Code and California Penal Code Section 836.5.

BACKGROUND

The Department of Planning and Development, Code Enforcement Section, is responsible for enforcement of the City Code sections relating to nuisance, zoning, signs, trailer camps and public camps, and the provision within the building ordinance relating to swimming pool fences. The citation and arrest authority will be used as an additional enforcement measure to assist Code Enforcement Officers in the enforcement of the aforementioned City Codes. The authority will allow officers to cite repeat and hardcore offenders. The citation procedure should serve as a deterrent to future violations. All the employees have completed the required law enforcement courses necessary to be granted citation and arrest authority recommended in this report and detailed in the attached resolution. These powers are limited in scope and exercised as a last resort.

FISCAL DATA

The vesting of citation and arrest authority to Code Enforcement Officers has no fiscal impact.

RECOMMENDATION

It is recommended that the City Council approve the attached resolution granting citation and arrest authority to the employees of the Department of Planning and Development, Code Enforcement Section, listed in the resolution.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SACRAMENTO:

SECTION 1.

In order to enforce certain provisions of the City Code, those persons hereinafter named are hereby granted citation and arrest authority for the purpose of enforcing those particular provisions of the City Code hereinafter specified, and for those limited purposes only.

SECTION 2.

Those individuals granted citation and arrest authority pursuant to Section 1, shall have no authority to use firearms in their activity and shall have citation and arrest authority only when on duty, during their regular working hours or when on special assignment at the direction of the Director of the Department of Planning and Development or his/her authorized designee.

SECTION 3.

Nothing herein shall be read to limit the power or authority of any duly appointed law enforcement officer of the City to enforce those Chapters of the City Code heretofore set forth.

SECTION 4.

This resolution is enacted pursuant to Article III of Chapter 30 of the Sacramento City Code and Section 836.5 of the California Penal Code.
