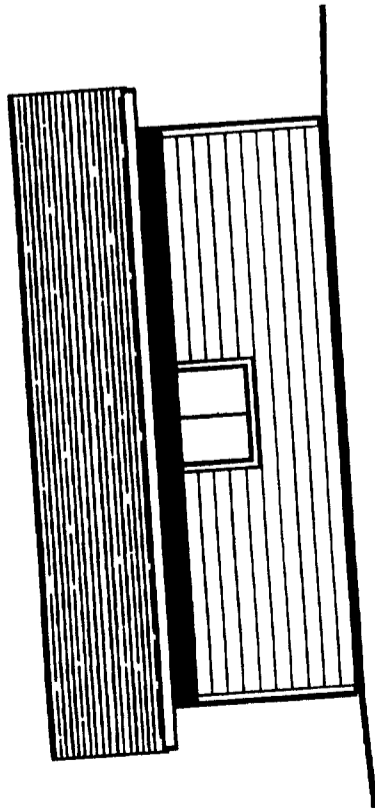

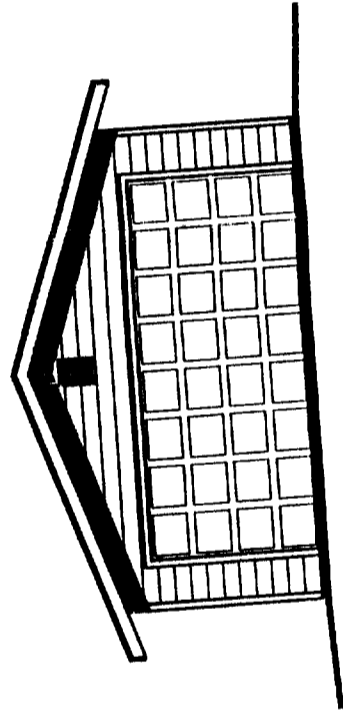

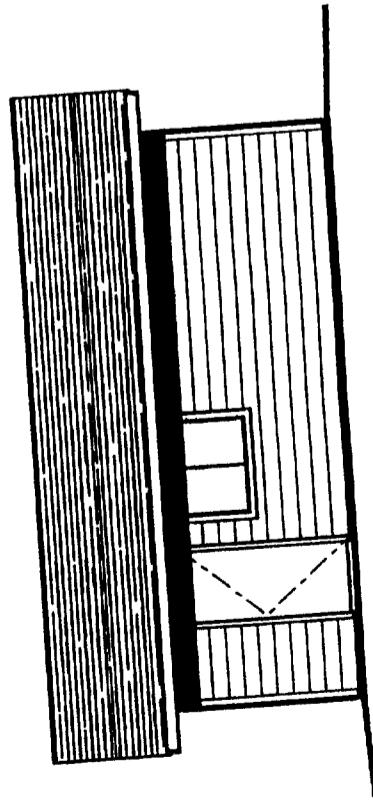
REAR ELEVATION (C)



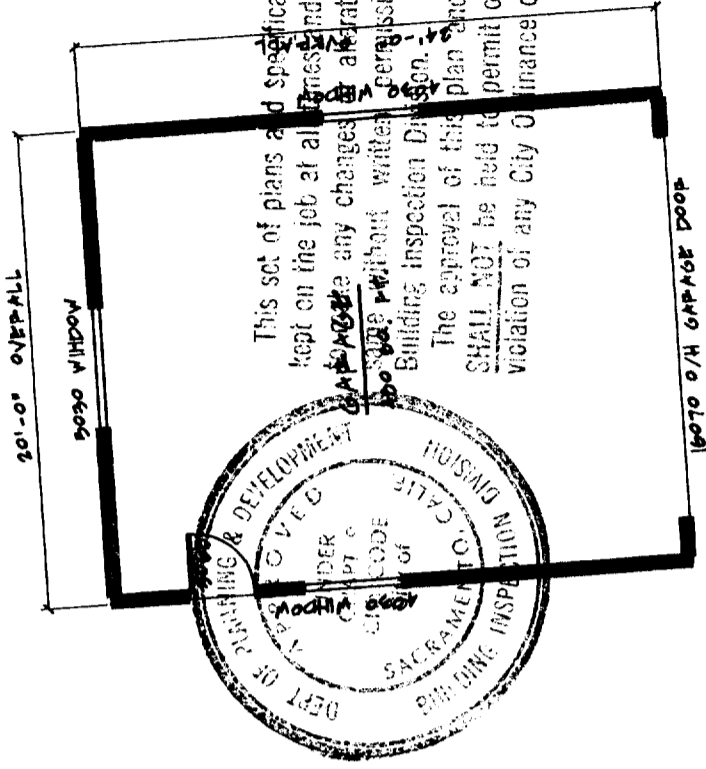
RIGHT ELEVATION (D)
