WHEREAS, Section 35 of the State Conservation and Planning Act states that: "It shall be the function and duty of each planning commission to prepare and adopt a comprehensive, long-term general plan for the physical development of the city, county or region, and of any land outside the boundaries thereof which in the commission's judgment bears relation to the planning thereof. Such plan shall be known as the Master Plan--"

WHEREAS, Section 45 and 46 of said Act specify that the Master Plan may include Community Design and Housing Plans.

WHEREAS, studies of housing conditions and provisions for slum clearance and redevelopment of blighted areas are considered an integral part of Community Design and Housing Plans.

WHEREAS, in conformity with the above authorization in the State Conservation and Planning Act and further in conformity with the request of the City Council of the City of Sacramento, of December 18, 1949, the City Planning Commission began a survey and study of conditions in the "West End" of Sacramento.

WHEREAS, the City Council on December 18, 1949, made a special appropriation of \$3,200 to the Planning Commission to make an urban redevelopment survey, studies and reports.

WHEREAS, the survey and studies were completed in November, 1949, and a preliminary report was submitted to the City Council by the Planning Commission as follows:

May, 1950 - First report, "The People of Sacramento Plan for 1960 Through Redevelopment".

June, 1950 - Second report, "Redevelopment Ideas for California's Capital".

October, 1950 - Third report - "Sacramento Needs Redevelopment".

WHEREAS, these reports have been prepared in accordance with requirements in the State Community Redevelopment Act and the National Housing Act of 1949.

WHEREAS, these reports contain much reference material which will serve as a general guide in acquiring land for redevelopment of blighted areas in the City of Sacramento.

WHEREAS, after holding a duly advertised public hearing a resolution adopting said redevelopment reports was passed on the 9th day of January, 1951, by the required two-thirds vote of the total membership of the Planning Commission.

NOW, THEREFORE, BE IT RESOLVED: That the City Council of the City of Sacramento, having received a recommendation from the Planning Commission that said reports be adopted as a part of the Community Design and Housing Section of the Master Plan of said City hereby adopts these reports.

Mayor Geisreiter addressed the Council suggesting that the Council appoint one of its members as a representative to the U. S. O.

After discussion, in which several members of the Council stated that they believed the appointment of a representative to the U. S. O. was a civic rather than a legislative matter, action thereon was indefinitely continued.

The City Manager, as well as Reg Renfree, Superintendent of Recreation, verbally reported, as previously requested by the Council, concerning cost data and upkeep of proposed new City Parks in south portion of the City.

Report re cost data & upkeep proposed new city parks, discussed; to be considered in connection with new Budget.

After considerable discussion, the sense of the Council was expressed to the effect that said matter be considered in connection with the new 1951-1952 Budget.

Report re proposed Bathing Beach American River, discussed; to be considered in connection with new Budget.

The City Manager verbally addressed the Council concerning proposed bathing beach on the American River, in response to request of the "Parks, River Park and Boat Harbor Committee" and quoted an estimated capitol outlay necessary for the construction of water and sewer lines, roads and parking areas in the beach area, in amount of \$39,000.00; and an estimated budget of supervised bathing area at River Park--American River from 10:00 A.M. to 9:00 P.M., in amount of \$8,521.00 annually.

The City Manager also presented informal figures as to possible revenues which could be derived from concessions.

Assistant City Engineer Fairbairn thereupon addressed the Council and rendered a verbal explanation of a preliminary plan of the proposed area involved.

The City Manager also presented the following memorandum from Dr. I. O. Church, City Health Officer:

"MEMORANDUM TO Bartley W. Cavanaugh, City Manager

Proposed Swimming Beach in River Park Area

This is to advise you that I have today received information from Morgan Stewart, district engineer, state department of public health, bureau of sanitary engineering, to the effect that additional sampling is soon to be undertaken on the American River to determine the extent of pollution coming from sewage disposal from the Folsom and Fair Oaks areas. I am told today that this testing might well indicate contamination or pollution of the river sufficient to make swimming unsafe.

In view of the above, I must reverse my former statement to the effect that the river water is to be considered safe.
