SUBJECT: SUMP 155 TRASH RACKS AND FOREBAY IMPROVEMENTS PROJECT (PN: WJ11) - TRANSFER FUNDS OF \$80,000 AND AWARD CONTRACT TO L.M. COMBS CONSTRUCTION, INC. FOR AN AMOUNT NOT TO EXCEED \$786,745.17

LOCATION AND COUNCIL DISTRICT:

The construction funded by this project will affect Sump 155 which is located at 6201 Camellia Avenue. Sump 155 is located in Council District 3 (see enclosed map).

RECOMMENDATION:

Staff recommends that the City Council adopt the attached resolution to:

- Transfer funds of \$80,000 from the Sump 157 Channel Lining Project (PN: WK71) to the Sump 155 Trash Racks and Forebay Improvements Project (PN: WJ11).
- Accept the responsive low bid from L.M. Combs Construction, Inc. for an amount not to exceed \$786,745 and award the contract.

SUMMARY

Bids were received from ten (10) contractors and opened by the City Clerk on January 30, 2002. Clyde G. Steagall, Inc. was the apparent lowest responsive bidder with a bid of \$694,425, but

subsequently withdrew their bid by certified letter dated January 31, 2002, due to a clerical error resulting in leaving out a major item of the bid. The apparent second low bidder, L.M. Combs Construction, Inc. submitted a bid or \$786,745 and is considered the lowest responsive bidder.

COMMITTEE/COMMISSION ACTION None.

BACKGROUND

Sumps 155 is a drainage pumping station that is designed to collect runoff from Basins 31 and 155 and discharge into the American River. Automatic screen cleaning equipment will allow the easier removal of debris from the channel, preventing the clogging of pumps and providing lower maintenance costs. Shotcrete lining of the approach channel will eliminate erosion, facilitate cleaning, and reduce maintenance costs. New transformer, switchgear and control equipment will be installed as part of the Department of Utilities' effort to upgrade out-dated electrical equipment at these facilities. The original switchgear is difficult to maintain due to its age. A programmable logic controller will also be installed which gives the City enhanced monitoring and control capabilities and is very useful during heavy storm events. In addition, new equipment will be installed to allow connection to an emergency mobile generator near the street if there is a SMUD power failure, which will avoid the need for access by a long and treacherous driveway.

- The Engineer's construction estimate for this project was \$680,397.
- Staff recommends contract award to L.M. Combs Construction, Inc., which exceeded the ESBE goals.
- The estimated completion date is August 15, 2002.

FINANCIAL CONSIDERATIONS

The total project cost including design, construction, inspection and contingency is \$938,000 based on the bid of \$786.745. As of February 8, 2002, the unobligated balance available for this project (425-500-WJ11-4820) was \$756,259, which is insufficient for award. Therefore, additional funding of \$80,000 will be required to complete this project. It is recommended that funds in the amount of \$80,000 be transferred from the Sump 157 Channel Lining Project (425-500-WK71-4820), in which there is an unobligated balance of \$400,000 as of February 8, 2002. A reduction of scope for the Sump 157 Channel Lining project has occurred which allows the project to be completed with the same benefit at a reduced cost; and, therefore, some of the project funding is no longer required.

ENVIRONMENTAL DETERMINATION

The Planning Services Division, Environmental Section, has reviewed the project and has determined that this project is exempt from CEQA under Section 15302(c) of the CEQA Guidelines. A notice of categorical exemption was filed with the County Clerk on March 12, 2001.

POLICY CONSIDERATIONS

This action is in conformance with City Code section, 3.60 Articles I & III, which provides that the City Council may award competitively bid contracts to the lowest responsible bidder and "advertising for bidding" requirements respectively.

ESBD CONSIDERATIONS

This project included participation goals of 20% for emerging and small business enterprises as required by Ordinance 99-007 and Resolution 99-055, relating to ESBD participation goals and

policies, adopted by the City Council on February 9, 1999. The responsive low bidder, L.M. Combs Construction, Inc. exceeded the ESBE goals with a participation level of 38.53%.
