**SUBJECT: AUTHORIZATION TO APPROVE SUPPLEMENTAL AGREEMENT NO. 1 TO CONSULTANT SERVICES AGREEMENT 98-106 WITH WESTIN ENGINEERING INC., FOR ADDITIONAL GEOGRAPHIC INFORMATION SYSTEMS (GIS) APPLICATION PROGRAMMING SERVICES FOR THE WATER BOOK GIS CONVERSION PROJECT FOR AN AMOUNT NOT TO EXCEED \$21,460 (PN:ZG01)**

Staff recommends that the City Council approve the attached resolution authorizing the City Manager and City Clerk to approve Supplemental Agreement No. 1 to Consultant and Professional Services Agreement No. 98-106 with Westin Engineering Inc., for GIS application programming services for an amount not to exceed \$21,460.

**SUMMARY**

Consultant and Professional Services Agreement No 98-106 was negotiated with Westin Engineering Inc., to provide project management tasks associated with the Water Book GIS Conversion Project. Westin Engineering Inc., provides expertise and experience in engineering information technology and GIS conversion management. This report requests that the City Council approve a resolution that authorizes approval of the proposed Supplemental Agreement No. 1 which will increase the not-to-exceed amount by \$21,460 for a total of \$121,294

**BACKGROUND INFORMATION**

The Water Book Digitizing Project (ZG01) was created to improve maintenance and accuracy of the water system information. This information is used primarily to develop and update the water map book used by the field crews to maintain the infrastructure. It is also used by the engineers and managers as a source of information used in the design and development of improvements and rehabilitation of the water system.

This project converts the manually maintained water information to Arc/Info, which the City's central GIS group decided would be the standard platform for all future GIS applications. Once the project is complete, in addition to maintenance and accuracy improvements, the data collected can be used to do analysis of system components and maintenance activity to help prioritize capital improvements. The data will also be able to be merged with other City GIS data (such as planning zones) that would help in system planning and development.

Westin Engineering Inc., was hired in March 1998 to help facilitate this conversion. Tasks accomplished under this agreement included project management tasks relating to the GIS conversion request for proposal, conversion specifications, and map scrub procedures.

Additional work under the proposed supplemental agreement will provide for application programming for map maintenance and map book printing applications based in Arc/Info and a map viewing and reporting application based in Arcview. A detailed description of this work is included in the attached Supplemental Agreement.

**ENVIRONMENTAL DETERMINATION**

This activity is exempt from the provisions of the California Environmental Quality Act (CEQA) under sections 15306 and 15307. The activity involves creating map maintenance and reporting programming for water system mapping and analysis.

**FINANCIAL CONSIDERATIONS**

The cost for Supplemental Agreement No. 1 is for an amount not to exceed \$21,460 and will be funded from the Water Fund Capital Improvement Program, 413-500-ZG01 which has an unobligated balance of \$449,122 as of July 20, 1999.

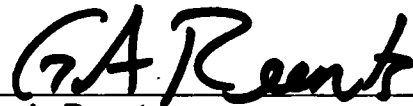
**POLICY CONSIDERATIONS**

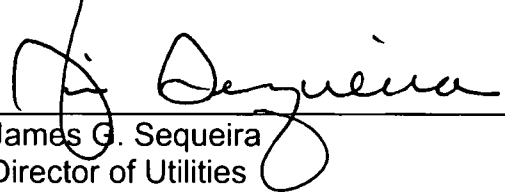
