SUBJECT: Approval of Parcel Map Agreement (P9198)

BACKGROUND INFORMATION

On February 10th, 1981, the Council adopted Resolution No. 81-097 which approved a tentative parcel map for 3621 Marysville Blvd., for property owned by Wiler Dennis and Doris J. Dennis.
