RESOLUTION APPROVING REPORT AND FIXING TIME AND PLACE

WHEREAS, the City Council of the City of Sacramento did heretofore, and on the 11th day of October, 19 51, order the preparation by the City Engineer of the City of Sacramento of a Report under the provisions of the "Special Assessment Investigation, Limitation and Majority Protest Act of 1931", and covering certain proposed improvements on

The Alley lying First Southerly of J Street, Running Easterly and Westerly from the Easterly line of 39th Street to a point 180 feet Easterly therefrom; and Alley lying First Easterly of 39th Street, running Northerly and Southerly from the Northerly line of K Street to a point 168 feet Northerly therefrom,

in the City of Sacramento; and

WHEREAS, said Report has been duly completed and presented to this City Council;


NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF SACRAMENTO:
