
Dear Building Inspector:

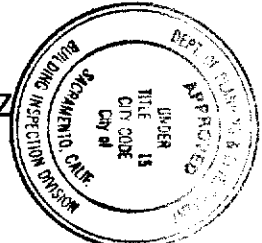
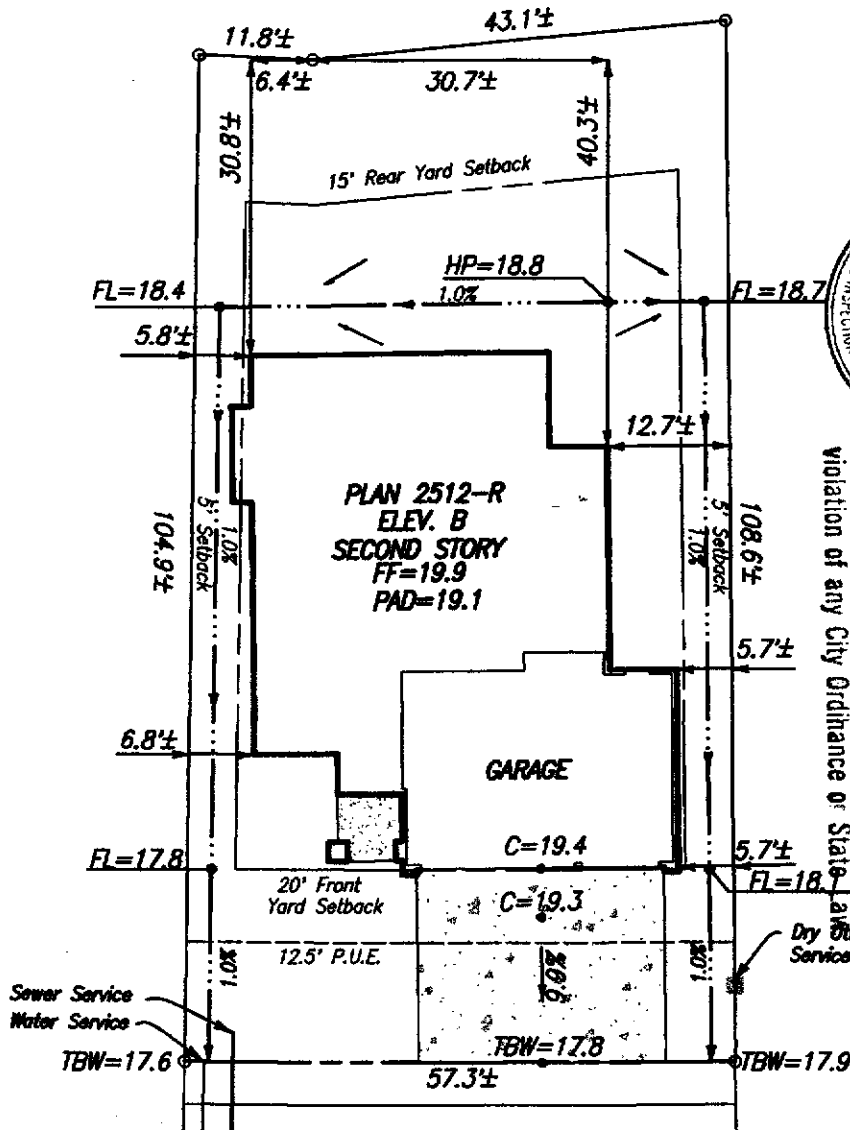
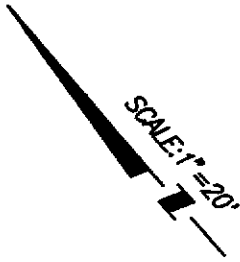
