SUBJECT: EXTENSION OF TIME FOR SAY GOLF TO RESURFACE AND RE-STRIPE
THE PARKING LOT AT WILLIAM LAND GOLF COURSE

LOCATION AND COUNCIL DISTRICT: Council District 4

RECOMMENDATION:

Capital City Golf division staff recommend that the City Council approve the attached resolution to extend the time period that Sacramento Area Youth Golf Association (SAY Golf) has to complete the resurfacing and re-striping of the parking lot at William Land Golf Course to September 30, 2001.

SUMMARY:

Capital City Golf staff is recommending that the City Council approve an extension of time for SAY Golf to complete the resurfacing and re-striping of the parking lot at William Land Golf Course. Contract #98-114 between the City and SAY Golf requires that the tenant (SAY Golf) complete the parking lot improvements by August 31, 2000. SAY Golf is requesting that they be given until September 30, 2001 to complete the parking lot improvements at William Land Golf Course.

BACKGROUND INFORMATION:

The City turned over the management, operation and maintenance of the William Land Golf Course to Sacramento Area Youth Golf Association (SAY Golf), a non-profit 501C3 organization, on September 1, 1998. The intent of the agreement between the City and SAY Golf was to accomplish capital improvements to the William Land Golf Course through fundraising efforts. SAY Golf has had a difficult time identifying a sponsor to assist with the parking lot improvement work. The agreement (#98-114) requires that SAY Golf complete the parking lot improvement work by August 31, 2000. SAY Golf is requesting that they be given until September 30, 2001 to complete the parking lot improvements at William Land Golf Course.

The Land Park Community Association (LPCA) was notified about SAY Golf's request for an extension of time to complete the parking lot improvements.

Since taking over the management, operation and maintenance of William Land Golf Course in September of 1998, SAY Golf has been successful in securing donations, sponsorships and grants to complete the following improvements at the City's William Land Golf Course:

- Constructed a new 3-hole golf learning center
- Constructed a scoreboard and picnic area (located adjacent to the learning center)
- Renovated the #1 tee
- Renovated the #9 green
- Trimmed trees around the learning center and between #1 tee and # 9 green

FINANCIAL CONSIDERATIONS:

SAY Golf intends to complete the parking lot improvement work as required by their agreement with the City. SAY Golf is asking only for an extension of time to complete the work.




