

RESOLUTION No. 761

Adopted by The Sacramento City Council on date of

WHEREAS, Under and by virtue of Section 23 of Ordinance No. 304, Fourth Series, it has been found necessary for the protection of the traveling public that the following streets or parts of streets be designated as Arterial Streets:-

ALHAMBRA BOULEVARD, from the north side of "E" Street to the north side of Broadway;

BROADWAY, from the west side of Front Street to the east side of Alhambra Boulevard;

"E" STREET, from the west side of Seventh Street to the west side of Twelfth Street;

FIFTH AVENUE, from the west side of Sacramento Boulevard to the west side of Stockton Boulevard;

FOLSOM BOULEVARD, from the east side of Alhambra Boulevard to the east City Limit;

FRANKLIN BOULEVARD, from the south side of Broadway to the south City Limit;

FREEPORT BOULEVARD, from the south side of Broadway to the west side of Twenty-first Street;

"H" STREET, from the west side of Alhambra Boulevard to the east City Limit;

"I" STREET, from the east side of Sixteenth Street to the west side of Alhambra Boulevard;

"L" STREET, from the west side of Thirteenth Street to the west side of Alhambra Boulevard;

LAND PARK DRIVE, from the south side of Broadway to the south side of Thirteenth Avenue;

"M" STREET, from the west side of Front Street to the west side of Ninth Street;

NINTH STREET, from the south side of "L" Street to the north side of Broadway;

RIVERSIDE BOULEVARD, from the north side of Broadway to the south City Limit;

SACRAMENTO BOULEVARD, from the east side of Alhambra Boulevard at Broadway to the south City Limit;

SEVENTH STREET, from the south side of "E" Street to the north side of "H" Street;

SIXTEENTH STREET, from the north side of Broadway to the north City Limit;

STOCKTON BOULEVARD, from the center line of Alhambra Boulevard at "P" Street to the south City Limit;

TWELFTH STREET, from the south side of "H" Street to the north City Limit;

TWENTY-EIGHTH STREET, from the south side of "J" Street to the north side of Broadway;

TWENTY-FIRST STREET AND FRANKPORT BOULEVARD, from the south side of "L" Street to the south City Limit;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:


That the aforesaid streets or parts of streets be, and hereby are, designated as Arterial Streets.
