**SUBJECT:** Metropolitan Arts Division - Increase in Appropriation/  
National Endowment for the Arts Grant

### SUMMARY

This report recommends an increase to the FY 1981-82 budget of the Metropolitan Arts Division to reflect funds relating to a National Endowment for the Arts' Expansion Arts Program Grant.

### BACKGROUND INFORMATION

On February 24, 1981, the City Council adopted Resolution No. 81-124 increasing the FY 1980-81 budget of the Metropolitan Arts Division by \$10,000. This award provides for support of the Division's Technical Assistance Program for the period covering January 1, 1981 through December 31, 1981.

### FINANCIAL DATA

In FY 1980-81 \$5,754.48 was expended and the balance of \$4,245.52 will be expended in FY 1981-82. There are no indirect costs associated with this grant and it does not require additional City Funds. Grant expenditures will be reimbursed from revenues associated with a \$10,000 grant from the National Endowment for the Arts.

### RECOMMENDATION

It is recommended that the City Council adopt the resolution to increase the budget of the Metropolitan Arts Division by \$4,245.52 for FY 1981-82 for support of the Technical Assistance Program.

ADOPTED BY THE SACRAMENTO CITY COUNCIL ON DATE OF

RESOLUTION AMENDING THE CITY BUDGET FOR  
FY 1981-82 FOR THE DEPARTMENT OF COMMUNITY  
SERVICES (METROPOLITAN ARTS DIVISION -  
NATIONAL ENDOWMENT FOR THE ARTS GRANT)

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

1. The continuation of a grant from the National Endowment for the Arts for the purpose of an expansion arts program requires an appropriation increase for the budget of the Department of Community Services.
2. The City budget for FY 1981-82 is hereby amended:
  - a. By adding thereto the sum of \$4,245.52 to budget 1-01-2281-8277-4258 relating to the expenditure of funds for the purpose stated in paragraph one above.
3. The above appropriation increase is supported by revenue forthcoming from the National Endowment for the Arts.
