**SUBJECT:** Resolution Authorizing Execution of Individual Project Agreement No. 1 between the City of Sacramento and the Redevelopment Agency concerning preparation of street improvement plans for the Ramona Hotel Project at 6th and J Streets

SUMMARY:

Presented herewith for approval is an Individual Project Agreement between the Redevelopment Agency and the City of Sacramento for the preparation of street improvement plans for the Ramona Hotel Project at 6th and J Streets.

BACKGROUND:

On August 3, 1982 the City of Sacramento and the Redevelopment Agency entered into a Memorandum of Understanding relating to the execution of agreements for physical improvements. This is the first Individual Project Agreement covered by the Memorandum of Understanding and relates to the preparation of street improvement plans for the Ramona Hotel project at 6th and J Streets.

FINANCIAL DATA:

The Redevelopment Agency has allocated \$17,000.00 for design of the subject project. There will be no cost to the City.

RECOMMENDATION:

It is recommended that the City Council approve the Individual Project Agreement by passage of the attached Resolution.
