9. SPORTS FIELD STUDY PHASE 1 RESULTS

Superintendent Alan Boyd reported on information compiled from long-term sports field user organizations regarding any unmet needs of the City's sports fields, as outlined in the staff report. Mr. Jordan Lang reviewed his role in this study and process.

Commissioners and staff discussed how this study and resulting information ties to statistical information, plans and priorities outlined in the *Parks and Recreation Master Plan* and the *Parks and Recreation Programming Guide*, and questioned if Sacramento is unique and should not be tied to statewide or national averages for types of recreation facility uses and needs. Also discussed were concerns about gender equity in field use; permitting processes and fee schedules; whether baseball fields should be converted to soccer fields; the need for additional lighting, parking areas and restrooms; resistance from residents around perimeters of parks with sports fields; funding challenges in developing more facilities in community and regional parks; Park Maintenance Services' efforts to "rest" and renovate heavily-used fields; the need for on-site signage to help keep people off the closed fields, and a recommendation to post information on the City's website on field closures for renovation purposes as well as for reserved park facilities.

Several citizens and youth from Sacramento United Soccer attended the meeting and spoke to this and the following agenda item. A roster was circulated for those who would like to participate in continued planning and activities to improve and expand sports fields.

Staff will report on the results of the second phase of the Sports Field Study this Spring, to include an inventory and assessment of non-City fields and the development of an overall plan to address issues with sports fields.

10. GRANITE REGIONAL PARK DEVELOPMENT, FIELD RENOVATIONS AND FUNDING

Staff reported on the continued development of recreation facilities in the park, funding for these improvements, and a continuing program of renovation of the existing sports fields. Commissioners discussed advocating to City Council the need to fund more lighted, all-weather sports fields. After further discussion on overall park and recreation needs in the community, and the lack of funds for regional parks, Chair Cooke volunteered to draft a letter to the City Council on behalf of the Commission to advocate for funding and the leveraging of funding through partnerships, etc. for Sacramento's regional park system.

COMMISSIONER'S IDEAS, QUESTIONS AND ANNOUNCEMENTS

Commissioner Deglow asked for an update on the City's actions to stop encroachment on City property in the Glenbrook area. Janet Baker responded that letters were going out to residents giving a final notice, and staff continues to develop an ordinance on this subject.

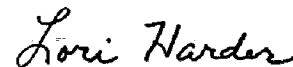

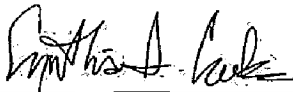
The Parks and Recreation Commission meeting adjourned at 9:45 p.m.
